June's Presentation:

Laws and Regulations regarding the collection of animals and plants off the coast of Florida

- If you are over 16, or planning on fishing off a boat or vessel, you must get a saltwater fishing license, which can be purchased at Sports Authority or Wal-Mart for only \$13.50
- It is illegal to take any stone crabs, blue crabs, or Blue land crabs, all which are very common off the coast. Stone crabs have black tipped claws, blue crabs look like stone crabs without the black-tipped claws, and blue land crabs can look exactly like fiddler crabs, so it would be wise to just not take any crabs from the coast.
- Any sea fan, sponge, or hard coral is illegal to take from the waters off the coast of Florida.
- Under no condition, is live rock legal to take. Live rock is defined by the FWC (Florida Fish and Wildlife Commission) as any solid material that has plant growth on it. That means any piece of wood, concrete, plastic, or stone that has even a little trace of algae on it would be defined as live rock and, if caught with it, the person who took it could be in serious trouble, and may even have to serve jail time.
- So, just keep under the law, obey the rules, and collect with caution, because the FWC and law enforcement officers often make random checks for illegal species in people's possession.
